- 4. IMPORTANCE: If you wish to vote for the resolution, tick in the box marked "FOR". If you wish to vote against a resolution, tick in the box marked "AGAINST". If no direction is given, your proxy may vote or abstain as he/she thinks fit. Your proxy will also be entitled to vote at his/her discretion on any resolution properly put to the class meeting other than referred to the notice convening the class meeting of the holders of the Shares.
- 5. This form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of corporation, must be either under its common seals or under the hand of an officer, attorney or other person duly authorized to sign the name.
- In order to be valid, this form of proxy together with the notarially certified power of attorney (if any) or other authority (if any) under which it is signed, must be delivered to Computershare Hong Kong Investor Services Limited of Rooms 1806–7, 18th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 24 hours before the time appointed for holding the meeting or adjourned meeting.
- 7. In the case of joint registered holders of any H Shares, any one of such persons may vote at the meeting, either personally or by proxy, in respect of such H Shares as if he/she was solely entitled thereto; but if more than one of such joint registered holders be present at the meeting, either personably or by proxy, that one of the said persons so present whose name stands first on the register of members in respect of such H Shares shall be accepted to the exclusion of the votes of the other joint registered holders.
- 8. The proxy need not be a member of the Company but must attend the meeting in person to represent you.
- Completion and delivery of this form of proxy will not preclude you from attending and voting at the class meeting of the holders of H Shares if you so wish. If you attend and vote at the meeting, the authority of your proxy will be revoked.
