- 5. This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, must be executed either under its common seal or under the hand of a director or other person(s) duly authorised to sign on its behalf.
- 6. In order to be valid, this proxy form of the holder of the Domestic Shares together with the power of attorney or other authorisation document (if any) shall be deposited by hand or by post at the Company's Registered Office of No. 12 Tai Hua Road, The 5th Avenue, TEDA, Tianjin, the PRC not less than 24 hours before the time for holding the Class Meeting (or the adjourned meeting thereof).
- 7. In the case of joint registered holders of Domestic Shares, any one of such persons may vote at the Class Meeting, either personally or by proxy, in respect of such Domestic Shares as if he/she were solely entitled thereto; but if more than one of such joint registered holders are present at the meeting, either personally or by proxy, the vote of the person so present whose name stands first on the register of members in respect of such Domestic Shares shall be accepted to the exclusion of the votes of the other joint registered holders.
- 8. The proxy need not be a member of the Company but must attend the Class Meeting in person to represent you.
- 9. Completion and return of this form will not preclude you from attending and voting at the Class Meeting if you so wish. If you attend and vote at the Class Meeting, the authority of your proxy will be revoked.
- 10. ANY ALTERATION MADE TO THIS FORM OF PROXY MUST BE INITIALLED BY THE PERSON WHO SIGNS IT.
- 11. Identification document must be shown by Shareholder(s) or proxies to attend the Class Meeting.
